LIMITED WARRANTY

Daikin North America LLC (hereinafter referred to as THE COMPANY), warrants that this humidifier (with the exception of the cylinder, which is not warranted), will be free from defects in material and workmanship appearing within the earlier of (a) five years after installation or (b) sixty-three months from the date of manufacture as evidenced by the humidifier's rating plate. No warranty is made against corrosion, deterioration, or failure due to unsuitability of substituted materials used as a result of compliance with government regulations, and THE COMPANY will have no responsibility under this warranty whatsoever until said product has been paid for in full.

THE COMPANY's obligations and liabilities under this warranty are limited to furnishing replacement parts to the customer, F.O.B. THE COMPANY's factory, providing the defective part(s) is returned freight prepaid by the customer, and said liability shall be limited to the original purchase price for the product. Parts provided under any warranty claim are warranted for the balance of the term of the warranty on the original humidifier, or 90 days, whichever is longer. IN NO EVENT WILL THE COMPANY BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE FAILURE OF THE HUMIDIFIER, WHETHER BASED ON BREACH OF EXPRESS OR IMPLIED WARRANTY, OTHER BREACH OF CONTRACT, NEGLIGENCE OR OTHER TORT.
